RATIONALE OF ACTIVITY


In a world subject to accelerated change, the breakneck peace of technological progress has given rise to new possibilities but at the same time dismantled those who were not nimble to adapt. In the Philippine context, we have a pervasive mindset that industries and other relevant private and government agencies may be slower to change and that disruption will hit gradually.

The continuously changing business landscape and fast-placed disruptions driven by technology, changing consumer demographics and lifestyles have made business models obsolete, government programs irrelevant and academic curriculum off-tangent with changing realities. We have lagged behind in terms of competitiveness, blaming government's bureaucracy, lack of infrastructure, political system, poor indifferent or incongruent services, policies and programs. While the pool of talents and skills lack the need of competency while available workers remain under-skilled.

The efforts to address "industry-academe mismatch" are fragmented and government support is lacking/detached or absent. Some government agencies launch programs of perceived importance; however, the lack of awareness, relevance and collaboration cause poor adoption nor engagement by intended beneficiaries.

As the engine and voice of Cebu's businesses community, the Cebu Chamber of Commerce and Industry, Inc. seeks the need to weave all sectors towards common agenda and close collaboration. CCCI continues to uphold its commitment in education development and workforce capability building through the Dual Education and Training (DET) framework. With the establishment of the Assessment, Certification and Accreditation Services (ACAS) within the Chamber, CCCI aims to support the development of globally competitive industries by creating a pool trained and certified workforce that can be matched with the requirements of the private companies for mid to high level qualified workforce; thus, contributing to the increase income of the youth and their families through gainful employment resulting to inclusive growth.

The ACAS Stakeholder Engagment Forum is a sequel of the HR Conference and Industry-Academe Summit in 2018 and Stakeholders Engagement Meeting with the schools conducted from Jult to August 2019.





- The participation of the Cebu Contractors Association is critical in the creation of Job Profiles.
- Potential partner to consider: Association of Carriers and Equipment Lessers (ACEL) through Mr. Jigger Escanedo
- AQC Assessment and Certification Arrangement: Flexibility of Training Plan in regards to the schedule of trainees in the company. Trainees shall be able to transfer and be assigned to different project sites of various companies.
- In-Company Trainers Training: Should be presented during the Cebu Contractors Association (CCA) Board Meeting. CCCI should focus on the benefits and savings of CCA in the recruitment
- In-Company Trainers Training Modules vs. CCAs Contractors Supervisor Training Program (Trade Supervisor and Engineer). Difference of the two programs should be laid down once CCCI presented ACAS to the Board of CCA,

BREAK OUT SESSION

WORKSHOP FLOW

- 1. Participants was divided into four (4) Industry-Academe Clusters:
 - Construction
 - Food Manufacturing
 - Tourism- Tour Operations
 - ICT- Creative
- 2. Each group had a tandem from the CCCI Secretariat made up of a facilitator who guided the discussions and the secretary document the proceedings. The secretary transcribed the answers of the group into the meta cards provided while the guide facilitated and answered questions or clarifications coming from the group.
- 3. Participants identified relevant skill-sets under their industry sector that can be bundled into a job profile. The focus questions provided are:
 - What skills are desired by the industry to become more competitive? Please describe the skills as succinctly and concretely. Can any of these be bundled?
 - What job profiles best describe sets of bundled skills.
- 4. Participants ranked the job profiles from 1-5 with one being the most desirable.
- 5. Participants from the Academe identified the job profiles they are committed to pursue.
- 6. In a carousel, the participants from the Academe went around to the other groups and affixed the name of their institution on the Job Profiles of the other industries which they are interested to take up.
- 7. Once the group was done answering, the secretary took a picture of the output and submitted it to the technical team for presentation.
- 8. An industry representative assigned from each cluster presented the output during the plenary.
